Hours of Operation

(Only available on School Days, including half days)

Morning care is from 7:00 AM until 7:50 AM

After care is from school dismissal until 6:00 PM

There will not be a charge for morning care (including Wednesdays) after 7:35 AM.

After care charges will begin at 3:35 PM for elementary, middle and high school students.

Daily Rates

Invoices will go out each Monday for the week prior via FACTS.

Grades K-5: \$11 - School half days flat rate \$20

Grades 6-12: \$9 - School half days flat rate \$20

Annual Rate

Please note: to receive the annual rate, families must sign up prior to August 22.

Families who sign up for the **annual** rate will receive a **15% discount**. Nine monthly debits will take place the first of each month (September 1 – May 1). If the debit day falls on a weekend or holiday, it will be deducted from your account the following business day.

You must be enrolled in auto-pay with FACTS to qualify for the annual payment plan.

Grades K-5: \$1683.00 (\$187.00/mo)

Grades 6-12: \$1377.00 (\$153.00/mo)

Payment Agreement: Read Carefully

Payments will be handled through FACTS Tuition Management. Payments that are not received by the due date will be charged a \$25 late fee. FACTS will assess a \$30 fee for NSF's. Students will be removed from the program if payment is 30 days late or have a past due balance of \$75.00+. SFCA reserves the right to terminate the child's enrollment in King's Crew if payments are continually late.

Accounts will be charged \$1.00 per minute for students not picked up by 6:00 PM. Families that are not permitted to use King's Crew will be charged the late fee rate of \$1.00 per minute beginning at the time of drop off until 7:35 AM for morning care and beginning at 3:35 PM until picked-up for afternoon care, in addition to the King's Crew Daily Rate.
